On the other, you are saying that NBFCs must shift from raising funds from banks. The fact is growth is required, and NBFCs reach those areas which banks cannot...

New book, our wholesale average size of loan is about ₹165 crore which is much lower than the old book. We are not doing any structured loans and by and large it will be loans that are cash-flow-backed...

There is also a new player (Jio Financial Services) in town and since there is a family alliance, will there be a business alliance as well?

Sharp pay cuts in small towns as more cos end remote work

The decline in compensation follows a 40% dip in IT sector hiring compared to last year

India's job market has shifted drastically since a year ago, when India Inc was on a hiring spree, offering generous pay packages, especially in tier II and III cities. According to experts, the resurgence of in-office policies has led to a decline in compensation by over 40% for candidates located in smaller towns and cities...

The difference in compensation, including city allowances, led to a 20-40% difference in salaries for candidates from small towns. Companies have moved between either side of the pendulum in the last year and half, said Hardeep Singh...

Post-covid, they wooded-tal from these towns and now are insisting everyone to work from office. Many employees are heading to satellite offices, and it will be taking some time for hybrid work culture to settle down. Singh added. A year ago, IT and FMCG firms were recruiting from cities such as Vijayawada, Coimbatore, Bhubaneswar, Visakhapatnam and Ahmedabad...
