Bharat Road Network Limited's Q1FY19 PAT rises 15 times to Rs. 727 lakhs Revenue increased to Rs. 1920 lakhs in Q1FY19 from Rs. 379 lakhs in Q1FY18

Kolkata, August 14, 2018: Bharat Road Network Limited (*BSE: 540700 / NSE: BRNL*), a leading roads and highways BOT company, has reported a robust growth of 15x Year-on-Year in its standalone Profit After Tax ("PAT") at Rs. 727 lakhs during the Quarter Ended 30th June 2018 as compared to Rs. 50 lakhs in the corresponding quarter last year. During the quarter, the company recorded standalone revenue of Rs. 1920 lakhs resulting in a strong growth of ~5x Year-on-Year against Rs. 379 lakhs in corresponding quarter last year.

The company witnessed a healthy growth in traffic across all its operating projects. During the quarter under review, the **average daily traffic (ADT) in passenger car unit ("PCU") terms grew by 10% Year-on-Year. Toll revenue across the portfolio increased by 9.6 % Year-on-Year to Rs 160 crs in the Q1FY19** as against **Rs 146 crs** in the corresponding quarter last year.

Commenting on the financial results **Mr. Bajrang Kumar Choudhary, Managing Director** said, "We are happy to witness buoyancy in the Roads sector triggered by a healthy growth in traffic volume and high capex allocation for highway development across the country. While growth opportunities have amplified exponentially, we at BRNL, remain committed to focus more intently on value creation through opex and capex optimisation rather than aiming solely for volume growth in the business."
